LEGISLATION: **ORD. AN ORDINANCE AMENDING SECTION 1443.04 OF THE CODIFIED ORDINANCES OF THE CITY OF BRUNSWICK BY INCREASING THE NEW CONSTRUCTION PERMIT FEE SCHEDULE FOR TYPE F AND TYPE S PERMITS.

WHEREAS: THE COUNCIL OF THE CITY OF BRUNSWICK HEREBY ORDAINS:

SECTION 1: That Section 1443.04 of the Codified Ordinances is hereby amended to read as follows:

“ TYPE F Floor Area x \$.~~80~~1.15/SF

TYPE S Floor Area x \$.~~80~~1.15/SF”

SECTION 2: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
