LEGISLATION: **RES. BACKGROUND: The Division of Police will be purchasing new firearms (pistols) in an amount not to exceed \$53,450, less the trade in of (54) fifty-four firearms totaling \$11,480 (see attached).

PURPOSE AND EXPLANATION: Request this as an emergency with suspension of the rules in consideration for the order and time needed to transition to the new weapons during spring range sessions.

AN EMERGENCY RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH VANCE'S LAW ENFORCEMENT FOR THE PURCHASE OF NEW WEAPONS FOR THE DIVISION OF POLICE IN AN AMOUNT NOT TO EXCEED \$53,450.00.

WHEREAS: Pursuant to Ohio Revised Code Section 721.15(B), it is hereby determined that the Division of Police has weapons that are obsolete, no longer needed and/or unfit for public purposes.

WHEREAS: THE COUNCIL OF THE CITY OF BRUNSWICK HEREBY RESOLVES:

SECTION 1: That the City Manager is hereby authorized to enter into an Agreement with Vance's Law Enforcement for the purchase of new weapons for the Division of Police in an amount not to exceed \$53,450.00.

SECTION 2: That the City Manager is hereby authorized to sell weapons in the possession of the Division of Police that are obsolete, no longer needed and/or unfit for public purposes simultaneously with the purchase of the new weapons, in an amount not less than \$11,480.00, to be credited against the purchase price of the new weapons.

SECTION 3: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety or welfare, and for the additional reason that immediate passage is necessary to obtain replacement weapons in time for the regularly scheduled spring range training sessions. Therefore, the same shall be in full force and effect from and after its passage by the required number of votes or from the earliest time allowed by law.
